European Alternatives is a transnational civil society organisation and citizens movement promoting democracy, equality, and culture beyond the nation state.

When we started running this organisation, we believed Europe could be a laboratory for political invention and progress with global implications, but only if we radically changed course. We felt that the current European regime was undermining its own claims to universal rights, democracy and justice. We rejected the idea that we must choose between the status quo and nationalism: we held Europe had to be reclaimed and reinvented, made hospitable to others and to other ideas.

At the same time, we knew that Europe had the resources to reinvent itself: a history of democratic invention, of human rights and responsibility, of art and intellectual endeavour, of dissidence, resistance and utopian action. We started small, a group of like-minded individuals with almost no material resources, only our energy, ideas and our email accounts, but it rapidly became clear that there was a need for an organisation, a structure, an institution, a medium, to empower a new generation of Europeans to act for a different future in multiple ways.

Today, 15 years later, we still reject the idea that there has to be a division between 'metropolitan elites' and 'ordinary people'. The lives of us all are politically and socially determined by forces that cross borders, and we can only try to have political agency by acting in a transnational way in solidarity with others who may be physically distant but in a similar circumstance. The relevant political division is between elites which profit from exploitation and a monopoly over power and influence, and those of us who believe an alternative future is possible. The task of European Alternatives is to contribute to connecting, organising and empowering these people across borders, acting locally. Accordingly, European Alternatives does not limit its action to one theme, topic or geographical area but endeavors to be generalist and transnational. In this report you will find at a glance some of our key actions and impact of the past few years.

# OUR STRUCTURE

European Alternatives is an ongoing experiment in creating a transnational grassroots organisation, which is committed to participation and democratic functioning, empowering its members both to influence internal decision-making, and take the initiative to propose and run new activities.

Working through our various cities, European Alternatives has over the past years developed innovative approaches to promoting European citizenship and fundamental rights by organising citizens' discussions, transnational campaigns, festivals, and conferences, by using innovative online methods (multilingual websites, podcasts, social media activism, online videos, magazines, web documentaries and more) and by involving excluded groups in activities with a European focus (migrant groups, local democracy groups, youth groups, artistic organisations).

**EA STAFF** is responsible for the implementation of the work programme, its communication and coordination of the EA community.

#### THE TRANSNATIONAL BOARD

of Trustees is legally empowered to oversee the running of the organisation, set its strategy and approve its work programme. It does so in dialogue with individual and organisational members, local groups and our partners.

He has edited with Greg Nielsen, Acts of Citizenship (London, 2008). Isin is currently conducting three main research projects: (i) concerning postorientalist conceptions of citizenship; (ii) concerning 'acts' especially those that constitute subjects as claimants of justice traversing frontiers; and, (iii) concerning 'digital citizenship' with a focus on governing conduct in cyberspace.



# ETTENNE **BALIBAR**

Etienne is Professor Emeritus of moral and political philosophy at Université de Paris X – Nanterre and Distinguished Professor of Humanities at the University of California, Irvine. He has published widely in the area of European citizenship and moral and political philosophy in general. His many works include Lire le Capital (with Louis Althusser, Jacques Rancière); Spinoza et la politique (1985): We, Citizens of Europe? (2001); Politics and the Other Scene (2002); L'Europe, l'Amérique, la Guerre. Réflexions sur la mediationeuropéenne (2003); Europe, Constitution, Frontière (2005).



Gianluca was among the cofounders of the first Italian Green political platform, in the City of Mantua. After his studies on urban and regional affairs in Venice, Paris and Berlin, he was political advisor to the Green Party in the European Parliament for ten years, as well as coordinator of the Spanish Green Party in Europe for two years. At the Anna Lindh Foundation for the dialogue between cultures, over

the last eight years (2005-2012), he has built a network of 4,000 organisations from more than forty countries between Europe, the Arab world, Israel and Turkey. He is author of several books, among which Walls, Tears and Za'tar (Nuovadimensione, 2007) and A Mediterranean Awakening (Nuovadimensione, 2013). He is a member of the Mediterranean Citizens' Assembly.



FFAELLA **BOLINI** 

Raffaella is International Director and a member of the National Board of ARCI, the largest cultural association in Italy with one million members and formed by 5.000 local community centers promoting citizenship, democracy and rights. She is also vice-president of the European Civic Forum, a member of the International Council of the World Social Forum, a member of the Executive Committee of the Euromed Network for Human Rights and a member of the Board of SOLIDAR.



Sigrid is the Secretary General of the "Akademie der Künste der Welt" (Academy of the Arts of the World) in Cologne, a member of the Board of Allianz Cultural Foundation, and a Trustee of Festspielhaus Hellerau/ Dresden. She is the founding director of Tanzquartier Wien.



**VAN PARIJS** 

Philippe Van Parijs studied philosophy, law, political economy, sociology and linguistics at the Facultés universitaires Saint Louis (Brussels) and the Universities of Louvain, Oxford, Bielefeld and California (Berkeley). He holds doctorates in the social sciences (Louvain, 1977) and in philosophy (Oxford, 1980).

He is Professor at the Faculty of economic, social and political sciences of the University of Louvain (UCL), where he has directed the Hoover Chair of economic and social ethics since its creation in 1991. He has also been a special guest professor at the KuLeuven's Higher Institute for Philosophy since 2006. From 2004 onwards he was for several years a Regular Visiting Professor of Philosophy at Harvard University.



**BRUGUERA** 

Tania is a Cuban installation and performance artist. She studied at the Instituto Superior de Arte in Havana and then earned an M.F.A. in performance from the School of the Art Institute of Chicago-She is the founder and director of Arte de Conducta (behavior art), the first performance studies program in Latin America, which is hosted by Instituto Superior de Arte in Havana. From 2003-2010. she was an Assistant Professor at the Department of Visual Arts of The University of Chicago, United States and is an invited professor at the University IUAV in Venice, Italy.



**SANDRO MEZZADRA** 

Sandro teaches political theory at the University of Bologna and is adjunct fellow at the Institute for Culture and Society of the University of Western Sydney. He has been visiting professor and research fellow in several places, including the Humboldt Universität (Berlin), Duke University, Fondation Maison des sciences de l'homme (Paris), University of Ljubljana, FLACSO Ecuador, and UNSAM (Buenos Aires). In the last decade his work has particularly centered on the relations between globalization, migration and citizenship. Among his works: "Diritto di fuga. Migrazioni, cittadinanza, globalizzazione" (ombre corte, 2006) and "La condizione postcoloniale" (ombre corte, 2008). With Brett Neilson he is the author of "Border as Method. or, the Multiplication of Labor" (Duke University Press, 2013).



Wang Hui is a Professor in the Department of Chinese Language and Literature at Tsinghua University in Beijing. He was named one of the top 100 public intellectuals in the world in 2008 by Foreign Policy, and is the author of The End of the Revolution. China's New Order, The Politics of Imagining Asia, and China's Twentieth Century.

# **BOARD OF TRUSTEES**



Alessandro is the Launch Director of Ashoka Italy. He's an Italian national and a global citizen passionate about social change and transnational movements. At European Alternatives he took responsibility for the Citizens Pact and Manifesto.



Lorenzo Marsili is a philosopher, activist, and one of the cofounders of European Alternatives. He previously worked in cultural journalism in London and Beijing, where he founded the journal Naked Punch Review. He was the initiator of the European Initiative for Media Pluralism, an international campaign demanding better protection for media pluralism and freedom at European level, and of Transnational Dialogues, a multi-year arts

exchange programme between cultural innovators in China, Brazil and Europe. In his book Citizens of Nowhere: How to Save Europe for Itself (Zed Books 2018, written with Niccolo Milanese), he tells the story of European Alternatives within a wider political and philosophical analysis of the crisis of the nation-state. He is a regular commentator on European media and has degrees in philosophy and sinology from the University of London.



Alberto joined the board of European Alternatives in December 2017. Alberto is an academic, civic advocate and public interest lawyer. He's Jean Monnet Professor of EU Law at HEC Paris and Global Professor of Law at New York University School of Law. He runs The Good Lobby, the first advocacy skill-sharing community aimed at connecting people with expertise with CSOs who need them in pursuit of the public interest.



Guilhem's first advocacy for democracy was through his job orientation. Believing in the importance of freedom of speech, he became a journalist. Willing to confront his views on news with the ones of people with different backgrounds, he's now working for an international broadcaster employing journalists from over 20 countries. Looking for a more active way to weight on the evolution of society and convinced that challenges can't be faced anymore at the national level, he became involved in European Alternatives in 2010. He's been the president of Alternatives Européennes in France since 2013.

# **TRANSEUROPA FESTIVAL**

On 19th March 2007, in a packed hall at the Courtauld Institute of Arts, Zygmunt Bauman opened the London Festival of Europe: many of the audience were surprised to see not some well established or official organisation behind the festival, but a group of young people. It was the first public act of European Alternatives.

The French poet Paul Valéry wrote of Europe as being a giant machine that runs on dreams and transforms the world around it. Our machine was miserable - with less than a couple of thousand euros we set about transforming this experience into a pan-European festival that would span the continent and provide the infrastructure to grow our ideals: for us, this is Transeuropa festival.

# At a glance

- TRANSEUROPA is a transnational festival taking place in as many as 15 cities simultaneously and encompassing several topics and activities in the areas of art and politics. From Belgrade to Barcelona, from London to Bratislava, from Cluj-Napoca to Paris, since the first edition thousands of activists across Europe have been invited to engage in this movement spanning dozens of cities across the continent.
- TRANSEUROPA is a moment of synergy and openness; a moment of gathering and a place from which it is possible to develop new perspectives, imaginaries and launch common projects and initiatives across Europe. It is the moment for European Alternatives to reaffirm its commitment to putting culture and arts at the centre of its vision of Europe.
- Beyond inviting people to think Europe differently, TRANSEUROPA aims at creating a shared space between people located in different countries and cities, where they can think and act together. A transnational space, where the feeling of belonging to one community is not linked to territoriality or nationality.
- The last edition of **TRANSEUROPA** took place in Porto (20-25 April 2022). Curated collectively and taking into account a plurality of voices, the programme actively participated in deconstructing spaces of oppression and works in building spaces of freedom and imagination to construct viable and long-term alternatives. The curatorial theme, Decolonize, Decarbonise, Democratize, focused on three key concepts shaping our world and our relationships today. Porto became the ideal location to take forward these concepts and rethink a new physical and conceptual space in which the relations between Europe, Africa and Latin America take a different shape.

# SCHOOL OF TRANSNATIONAL ORGANISING

In The School of Transnational Organizing, everyday people, social movement builders, trade union organizers, migrant workers, climate justice activists as well as marginalized communities meet to learn the tools and skills to master the lost art of organizing solidarity and together shape the landscape of what we think is possible. We create brave spaces involving different people: allowing us to overcome the deep sense of powerlessness many of us share and enabling people "to turn the resources they have into the power they need to make the change they want" (Marshall Ganz). With a wide community of trainers, facilitators, and educators, we inspire, train, and support new popular pioneers, organizations, and movements to spread political hope, courage, and joy in their countries, cities, and communities. Our offline and online educational programs and classes are free of charge and do not require prior academic knowledge or political experience. We believe that only when people see more and more people acting collectively and building capacity for a common future can we keep believing in democracy and solidarity.

Projects within the School of Transnational Organizing include:



# **Academy of Migrants Organizing**

The Academy of Migrant Organizing is a migrant organizing program promoting a new strategic way of transformative organizing as it was and is being practiced in many unions and movements around the world. The program is specifically aimed at migrant, refugee and BIPoC organizers in Germany, with the goal of starting a joint process of reflection, research and education with three public events mainly designed by the expert group: We want to lead the discourse about identity and solidarity of and with migrants out of the political dead-end. Connecting to recent campaigns for the right to vote for migrants as well as affordable housing, health care, workers rights, and fundamental rights in Germany we thus want to engage in a critical discourse about political representation, agency and transformative community organizing, as diaspora communities, social movements and trade union campaigns show that migrants are at the forefront of the struggles of the last decade.

# **Mobile University for Migrant Workers**

The Mobile University for Migrant Workers is an educational program aimed at expanding and developing migrant workers' awareness of rights and their political capacity to effect change.

Over the course of three years, European Alternatives, the School of Transnational Organizing, and their partners across labor unions and academic institutions aim to build a dialogical and relational organizing and colearning process that supports migrant workers on the frontlines of care, agriculture, delivery, tech, logistics, aviation, and transportation. Through this process, we not only work together to expand self-organizing capacities, but to transform and democratize legal and representational structures through which migrant workers channel their power.

During the first phase of the project in 2022, we organize different storytelling sessions and legal advice, organizing trainings, migrant history classes and community events, as well as two summits (in collaboration with documenta Institute and Theater Bremen) and an online town hall meeting, to gain initial insights on how migrant workers can become stronger together and have a common voice in the German political discourse. This knowledge and tools will finally be shared with the public in our Migrant Organizing Toolbox and the Online Handbook for Transnational Organizers.

# **Youth Movement & Campaign Accelerator**

The Youth Movement & Campaign Accelerator offers European youth and community leaders a way to engage in, and build, European democracy, by establishing a transnational network able to connect national and local issues to EU-level policymaking. Our newest youth education program aims to increase the engagement of young people and their communities in constructing European democracy by the creation of a network of over 60 young people aged 18-30 from different European countries, who will have been trained in activating their local communities. articulating their issues and demands, and moving them to take collective action. In synergy with other ongoing projects like the Assemblies of Solidarity and the Academy of Migrant Organizing, and drawing from the experience and resources of the Citizens Take Over Europe coalition, the Youth Movement & Campaign Accelerator connects young activists and organizers with a broader network of individuals and organizations throughout Europe - as a trove of resources and connections that will empower them to lead increasingly impactful campaigns on the ground. This tight-knit network of engaged young European citizens and organizations will serve as a link between European institutions (and especially the Parliament) and their citizens and especially frontline communities, thus promoting the active participation of young European citizens ahead of the 2024 European Parliament elections.

# **Movement Learning Catalyst**

This year-long+ programme aims to nurture the interconnected movements and responsive strategies needed to challenge the interlocking systems of oppression we face today. It combines high quality training, an action learning framework, as well as cross organisational and movement networking.

The programme is designed as a transversal movement project – connecting different struggles and communities across barriers of gender and sexuality, race and ethnicity, social class, dis/ability and others. The course places action-learning, deep ongoing reflection, and building solidarity-based relationships at its core. In addition to exploring key themes related to transversal and transnational movement building, the programme aims to model these practices and provide a well designed framework for ongoing action-learning and relationship building. The programme is designed to strengthen our capacity to embed learning across our different movements' practices, so we can continue to learn from experience, design creative and testable interventions, and build strategic approaches that can respond to the everchanging conditions we struggle within.

Citizens Take Over Europe emerged in the spring 2020 amidst the Covid-19 pandemia. It is composed of a group of more than 50 civil society organizations, citizens and residents from across Europe, joined in a common effort to promote a forward-looking and citizenscentered European democracy. The coalition believes that it is fundamental for people in Europe to organize across borders and design the Europe that we want: "a Europe that cares and is taken care of".

# **Assemblies of Solidarity**

Our Assemblies of Solidarity are a series of citizens-led events, meaning organised by and for citizens and residents of the EU, aiming at connecting different marginalised groups. Citizens assemblies are one of the most accessible tools at civil society's disposal as a form of direct participative democracy.

The assemblies consist of a series of events and participatory moments co-created and coorganised by citizens to raise awareness on key topics related to:

- Democracy and fundamental rights.
- Social Europe and health.
- Environment and climate change



The Assemblies of Solidarity result in the cocreation of a feedback mechanism between EU citizens and the EU institutions (Parliament, Commission and Council), a package of petitions to promote the right to petition and other participatory democracy tools. We believe that European democracy must be based on innovative engagement formats, fostering the relationship and dialogue between citizens throughout Europe and their capacity to give useful inputs, reports and testimonies that can help European decision makers develop more informed policies.

The goal for European Alternatives is to showcase successful examples of Assemblies organised at local, national and European levels so as to promote the implementation of permanent European Citizens Panels as a viable and sustainable institution in European politics. Participative democracy should go hand in hand with the current representative democratic institutions in place, as a way to re-establish the trust and interest for civic participation, especially for the usually underrepresented communities.

# **Generation D Liberation**

With the project Generation D-Liberation, Citizens Takeover Europe and European Alternatives welcomed young people to show that all Europeans – including youth – have the right and the wish to say what the future of Europe should look like. We invited youth across different countries in Europe to organise their own citizen deliberation and draft their recommendations for the future of Europe. The objectives of the project are to develop and test a methodology for deliberation at school level that can be used by students and schools in order to promote youth engagement and political debates and recommendations. We also aim to promote youth engagement, school deliberations and to bring the voices of school students to their political representatives creating a meaningful dialogue among them.

# **EU Democracy Rally**

The EU Democracy Rally is a platform supporting people of all ages in their active citizenship. As partner organisations from all over Europe, we developed a training programme helping all of us hone our democracy skills and fine-tune our projects of social and political change. The aim of the project is to support citizens of all ages and young people in particular in the further development of our democracies. With this project we are working to enhance the direct participation of citizens in our democracies and help our societies focus on the ecological transition, the reduction of inequalities, and the improvement of the general quality of life. The first rally brought together around 30 young people in Luxembourg to participate in a one week programe on the topic of active citizenship.



# **ROOM** TO BLOOM

Room to Bloom is a platform and network bringing together feminist artists with a migration background who create ecological and postcolonial narratives of Europe. By associating artists and creators who - too often – occupy a peripheral place in the world of arts and places who are considered to be geographically peripheral, Room to Bloom aims at building a discourse on European Culture that is fully built on the experience and knowledge of the periphery and to bring it back to the centre.

Beyond a few famous faces, women and migrants struggle to be effectively contributing to the making of the European cultural and artistic discourse, not from a lack of ideas or capacities but because the structural obstacles they face are not of those that one can easily fight individually.

Room to Bloom recognises that it is more than time to build on that and provide artists and cultural operators to navigate patriarchalism and racism in the world of arts and to open up the space for them to bloom in a transnational Europe. The platform promotes emerging feminist artists and provides them with tools to operate in the European cultural scene. The platform is jointly coordinated by European Alternatives, AthensSYN, Avtonomi Akadimia, Studio Rizoma and the Museum of World Cultures.

# RESEARCH & ADVOCACY


European Alternatives constitutes a unique organisation in that it combines political, social and artistic projects taking place simultaneously in many different cities and with different formats. For this reason, we combine our work with academic research in cooperation with different universities, research centres and educational institutions.

# **Artsformation**

Artsformation is a research project exploring the intersection between arts, society and technology. With this project we aim to understand, analyse, and promote the ways in which the Arts can reinforce the social, cultural, economic, and political benefits of digital transformation. Artsformation investigates the potential of the Arts to intervene in critical social issues, with a view to remedying a range of abusive and exploitative aspects of digital technologies, such as labour politics, privacy and education.

So far with Artsformation we've organised artistic residencies, published academic research, participated in international artistic events such as transmediale or LABS, and hosted workshop with young artists on topics such as the impact of the Tik-Tok algorithm in our private and professional lives.

# **Workers Without Borders**

Workers without Borders advocates for the European institutions to do more to protect the rights of workers who move. In particular, it calls on the newly established European Labour Authority to take initiative in order to protect the rights of young workers and people in precarious forms of employment.

Through researching the risks to the rights of these workers, as well as best practices of trade unions and governmental agencies to protect these rights, the project will produce policy recommendations and promote structured dialogue between young and precarious workers and EU institutions.

# FIERCE: Feminist Movements Revitalizing Democracy in Europe

FIERCE aims to revitalize the alliances between the feminist movement, civil society and political decision makers. We envision the possibility to rekindle the movement-institution relationship by means of a multidimensional, bottom-up and impact-oriented approach.

FIERCE will kick off in the Autumn of 2022 and it will work to produce shared best practices of feminist mobilisations across Europe, strategies for countering far right in front of a growing anti-feminist and anti-gender movements, discourses, activities and the establishment of a strong network of feminist movements and public actors able to to defend and advance women's rights.

# **Trust Without Borders**


Trust Without Borders is a research project in cooperation with the University of Siegen that aims to determine the status quo of European solidarity and pathways towards a future Europe of solidarity. It brings together civil society with academia and political decision-makers to address the most pressing trust and solidarity issues of the EU and to develop proposals and recommendations for action. In line with European Alternatives' mission we focus on the needs and claims of civil society actors and activists to expand their transnational networks, strengthen collective action and knowledge across borders, and promote policy changes in the EU.

Over the three years (2021 - 2023), European Alternatives, together with the Department of European Political Sociology at the University of Siegen, will investigate what the real state of transnational trust and distrust in each other, in other member states, and in EU institutions is. The focus is on people's cross-border experiences and connections, which we want to discuss in focus groups and public events in Germany, Italy, and Poland.

# **Democracy Doesn't Exist, We Make It!**

Democracy Doesn't Exist, We Make It! is a research project and artistic exhibition about the importance of democratic engagement organised in cooperation with the Museum of World Cultures in Gothenburg. The exhibition is based on research from the V-Dem Institute, measuring the state of democracy in the world. Their research shows that the survival of democracy depends on people being active and holding their governments to account when democracy is being restricted. Democracy cannot be taken for granted and it cannot survive without people getting involved.

As part of the research and exhibition, we interviewed 15 activists from across the world and asked them to connect a personal story in their experience as activists with a daily life object. What does a duck have to do with democracy? What is the connection of a little taxi-toy with participation in democracy? The videos and objects gathered by our protagonists will be exhibited in the Museum and displayed in an ad-hoc app for young students in highschools.

Training, organising and networking communities, movements and individuals to contribute to an ecosystem of transformative power.


Co-creating a shared theoretical basis and common political objectives amongst our communities and shifting public political discussion towards transnational democracy, equality and justice.


For EA it is also an important priority placing an emphasis on the development of our organisation and staff. Therefor, we aim to:
